

Major Map: Bachelor of Science in Nursing – RN-BSN Program Catalog Year: 2011-2012

The following is a sample course of study. It is the Student's responsibility to ensure that all program requirements are met. This guide is not a substitute for academic advisement. *Your path to graduation may vary slightly based on factors such as transfer work from other institutions of higher learning and your nursing program. You are responsible for checking prerequisites to any courses.*

This Major Map is only for CURRENT Registered Nurses.

Of the 120 required credits for the BSN, 28 credits are from prior Nursing coursework, 36 are from the RN-BSN coursework, and 56 are from General education hours. If transferring general education credits do not total at least 56(actual number is 50 since N345 & N395 count towards 6 of the 56), then your Personalized Plan of Study will reflect this as "upper division general education hours". Below is a sample Full Time Plan of Study; however, there are several Part Time plans available for the convenience of the student.

No transfer work will be accepted within the last 30 credit hours of the BSN degree.
